Dear Friends:

This past year has been like no other. The Covid-19 pandemic to date has killed over a half-million Americans. The pandemic drastically altered lives. Many of us lost loved ones. Others lost jobs. Feeding our families became a struggle for many. We are unsure when a new normal will emerge.

When the stay-at-home orders began in March, the needs of children whom we serve did not pause. Children in foster care and foster care parents did not go into hibernation because of a pandemic. Community families in crisis do not stabilize because of a deadly disease. This has forced us to take a perspective look at this long term. This is not a quick fix. We needed to continue to support and serve-pandemic or no pandemic. Our good work is done with our front-line CASA volunteers. We needed to recruit and train more volunteers in our community. Therefore, we went to a virtual training format. Last year we trained 118 new volunteers to ensure that our children are not left behind. Our volunteers continued to visit children virtually and submit court training reports. Juvenile Court Judges remarked that CASA of Cook County was the only entity they could depend on to gather relevant information about the children.

Foster children and the courts were depending on CASA to continue to be the “eyes and ears of the court” for the best interest of the child. We continued to advocate for children however, we had the Victims of Crime Act (VOCA) federal funds eliminated and Illinois CASA network funds slashed from our budget. Negative adjustments to our budget could not have come during a worse time. Most of our traditional fundraising mechanisms such as the Bank of America Chicago Marathon and other in-person events, ceased due to the pandemic. This year we are in desperate need of a half- million dollars to continue to serve current CASA children, recruit and train new volunteers and meet the increased demands for our services.

As the Black Lives Matter movement sounded the call for social justice, many of our staff and volunteers marched for a world where no one needs to fear the police or other societal institutions. As an organization, we strive to look at our systems and unconscious bias. We recognize the roots of social inequities run deep into the child welfare and juvenile justice systems which serve a disproportionate number of black and brown children in care. We are committed to work against any disparities and continue to foster opportunities that benefit our clients.

This Annual Report is a celebration of our volunteers, staff and board who continued CASA child advocacy throughout the pandemic because foster children lives matter. We stand in awe and are humbled by our remarkable volunteers, staff, and donors for what they have done. They stepped up when others stepped back. This Annual Report recognizes these incredibly selfless individuals. There are many great reasons to continue to support our organization, and hopefully a few of the examples and resources I list below will entice you to help us continue this mission of serving CASA children in a major way. Commit today to do more, give more time, and donate more to a child victim of abuse and neglect. Again, WE need YOU to partner with us to do this impactful work.

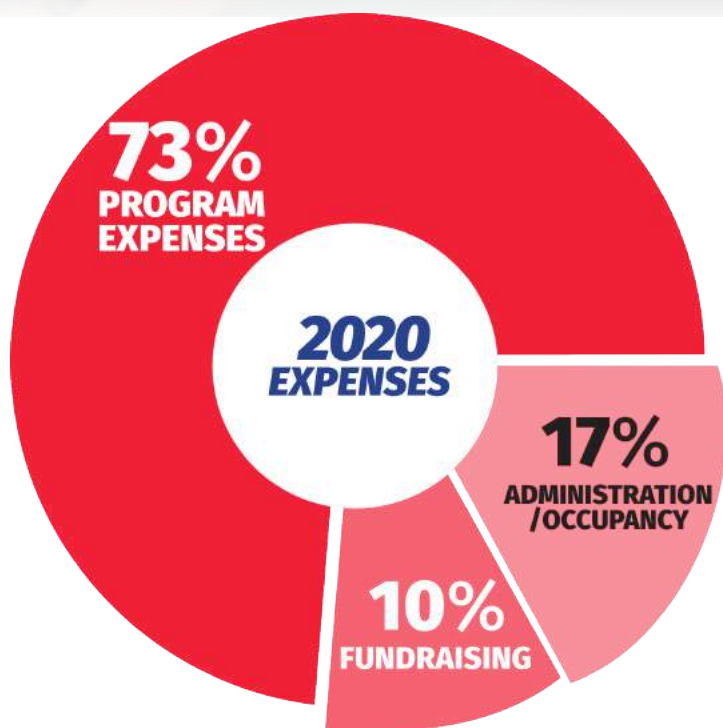
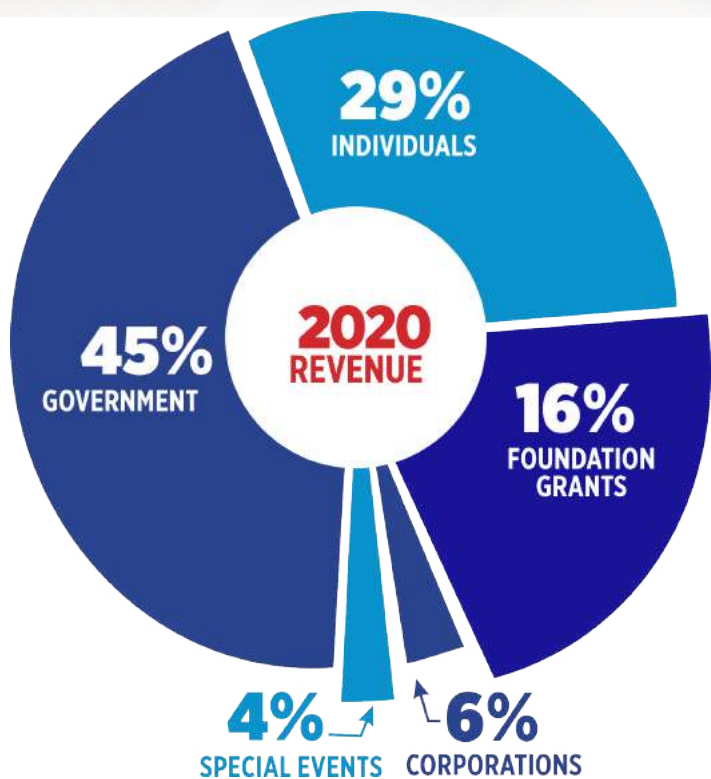
